Roche Fellowship in Clinical Oncology unveiled in Halifax

Cancer research in Nova Scotia received a boost with the announcement on June 27, 2006 by *Cancer Care Nova Scotia* and Capital Health of the establishment of the *Roche Fellowship in Clinical Oncology*.

The donation of \$225,000 by **Hoffmann-LaRoche Limited (Roche)** provides funding for the recruitment and salary costs of one clinical research fellow, in each of the next three years, to join the medical oncology team at Dalhousie University's Faculty of Medicine and Capital Health.

The clinical and research activities of the first *Roche Clinical Research Fellow* will focus on breast cancer. The fellow will join *Cancer Care Nova Scotia*'s Breast Cancer Site Team and will dedicate 50% of his/her time to support a medical oncologist in treating and caring for breast cancer patients. The remaining 50% will be dedicated research time with an assigned mentor and supervisor to conduct a clinical research project in breast cancer.
